

**PhillipMart Announces Pre-IPO Share Price of
 Jinxin Fertility Group Limited (Stock code: 01951)**

(Hong Kong – 24 June 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Jinxin Fertility Group Limited (“JXR”; stock code: 01951) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for JXR on PhillipMart were HK\$10 and HK\$9.11. The price closed at HK\$9.83 per share, 15.11% higher than its offer price of HK\$8.54. The price opened at HK\$9.6, with the most actively traded price of HK\$9.6 per share, and a turnover of 2,642,000 shares. The total trading volume reached 36,282,000 shares with **total turnover of HK\$352,473,760**. The final price of JXR, to debut trading tomorrow has been fixed at HK\$8.54 per share.
