

**PhillipMart Announces Pre-IPO Share Price of
 AM Group Holdings Limited (Stock code: 01849)**

(Hong Kong – 25 Jun 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of AM Group Holdings Limited (“AM Group”; stock code: 01849) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for AM Group on PhillipMart were HK\$0.64 and HK\$0.52. The price closed at HK\$0.54 per share, 16.92% lower than its offer price of HK\$0.65. The price opened at HK\$0.64, with the most actively traded price of HK\$0.54 per share, and a turnover of 3,500,000 shares. The total trading volume reached 11,570,000shares with **total turnover of HK\$6,421,700**. The final price of AM Group, to debut trading tomorrow has been fixed at HK\$0.65 per share.
