

**PhillipMart Announces Pre-IPO Share Price of
 Impro Precision Industries Limited (Stock code: 01286)**

(Hong Kong – 27 Jun 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Impro Precision Industries Limited (“Impro Precision”; stock code: 01286) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Impro Precision on PhillipMart were HK\$3.55 and HK\$3.12. The price closed at HK\$3.31 per share, 10.33% higher than its offer price of HK\$3. The price opened at HK\$3.15, with the most actively traded price of HK\$3.35 per share, and a turnover of 715,000 shares. The total trading volume reached 1,119,000shares with **total turnover of HK\$3,692,700**. The final price of Impro Precision, to debut trading tomorrow has been fixed at HK\$3 per share.
