

**PhillipMart Announces Pre-IPO Share Price of
 Tu Yi Holding Company Limited (Stock code: 01701)**

(Hong Kong – 27 Jun 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Tu Yi Holding Company Limited (“Tu Yi Hldg”; stock code: 01701) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tu Yi Hldg on PhillipMart were HK\$0.52 and HK\$0.47. The price closed at HK\$0.475 per share, 8.65% lower than its offer price of HK\$0.52. The price opened at HK\$0.485, with the most actively traded price of HK\$0.5 per share, and a turnover of 6,456,000 shares. The total trading volume reached 24,800,000 shares with **total turnover of HK\$12,235,800**. The final price of Tu Yi Hldg, to debut trading tomorrow has been fixed at HK\$0.52 per share.
