

**PhillipMart Announces Pre-IPO Share Price of  
 Grown Up Group Investment Holdings Limited (Stock code: 01842)**

(Hong Kong – 27 Jun 2019 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Grown Up Group Investment Holdings Limited (“Grown Up Group”; stock code: 01842) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Grown Up Group on PhillipMart were HK\$0.61 and HK\$0.51. The price closed at HK\$0.54 per share, 8% higher than its offer price of HK\$0.5. The price opened at HK\$0.57, with the most actively traded price of HK\$0.53 per share, and a turnover of 57,288,000 shares. The total trading volume reached 76,712,000shares with **total turnover of HK\$41,092,280**. The final price of Grown Up Group, to debut trading tomorrow has been fixed at HK\$0.5 per share.
