

**PhillipMart Announces Pre-IPO Share Price of
 Shinelong Automotive Lightweight Application Limited (Stock code: 01930)**

(Hong Kong – 27 Jun 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Shinelong Automotive Lightweight Application Limited (“Shinelong”; stock code: 01930) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Shinelong on PhillipMart were HK\$1.24 and HK\$0.91. The price closed at HK\$1.23 per share, 39.77% higher than its offer price of HK\$0.88. The price opened at HK\$0.91, with the most actively traded price of HK\$1.13 per share, and a turnover of 1,084,000 shares. The total trading volume reached 5,660,000shares with **total turnover of HK\$6,330,920**. The final price of Shinelong, to debut trading tomorrow has been fixed at HK\$0.88 per share.
