

**PhillipMart Announces Pre-IPO Share Price of
 Silver Tide Holdings Limited (Stock code: 01943)**

(Hong Kong – 27 Jun 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Silver Tide Holdings Limited (“Silver Tide”; stock code: 01943) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Silver Tide on PhillipMart were HK\$0.45 and HK\$0.375. The price closed at HK\$0.41 per share, 18% lower than its offer price of HK\$0.5. The price opened at HK\$0.4, with the most actively traded price of HK\$0.42 per share, and a turnover of 2,350,000 shares. The total trading volume reached 10,420,000shares with **total turnover of HK\$4,333,000**. The final price of Silver Tide, to debut trading tomorrow has been fixed at HK\$0.5 per share.
