

**PhillipMart Announces Pre-IPO Share Price of
 Homeland Interactive Technology Ltd. (Stock code: 03798)**

(Hong Kong – 3 Jul 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Homeland Interactive Technology Ltd. (“Homeland Int”; stock code: 03798) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Homeland Int on PhillipMart were HK\$2.05 and HK\$1.4. The price closed at HK\$1.9 per share, 40.74% higher than its offer price of HK\$1.35. The price opened at HK\$1.4, with the most actively traded price of HK\$1.8 per share, and a turnover of 2,386,000 shares. The total trading volume reached 14,630,000shares with **total turnover of HK\$26,748,280**. The final price of Homeland Int, to debut trading tomorrow has been fixed at HK\$1.35 per share.
