

**PhillipMart Announces Pre-IPO Share Price of
 Khoon Group Limited (Stock code: 924)**

(Hong Kong – 4 Jul 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Khoon Group Limited (“Khoon Group”; stock code: 924) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Khoon Group on PhillipMart were HK\$1.47 and HK\$0.68. The price closed at HK\$1.06 per share, 112% higher than its offer price of HK\$0.5. The price opened at HK\$0.68, with the most actively traded price of HK\$1 per share, and a turnover of 1,608,000 shares. The total trading volume reached 13,280,000 shares with **total turnover of HK\$14,044,720**. The final price of Khoon Group, to debut trading tomorrow has been fixed at HK\$0.5 per share.
