

**PhillipMart Announces Pre-IPO Share Price of
 CIMC Vehicles (Group) Co., Ltd. (Stock code: 1839)**

(Hong Kong – 10 Jul 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of CIMC Vehicles (Group) Co., Ltd. (“CIMC Vehicles”; stock code: 1839) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CIMC Vehicles on PhillipMart were HK\$6.48 and HK\$6.1. The price closed at HK\$6.18 per share, 3.13% lower than its offer price of HK\$6.38. The price opened at HK\$6.4, with the most actively traded price of HK\$6.2 per share, and a turnover of 1,207,000 shares. The total trading volume reached 5,593,000shares with **total turnover of HK\$34,690,855**. The final price of CIMC Vehicles, to debut trading tomorrow has been fixed at HK\$6.38 per share.
