

**PhillipMart Announces Pre-IPO Share Price of
 IVD Medical Holding Limited (Stock code: 01931)**

(Hong Kong – 11 Jul 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of IVD Medical Holding Limited (“IVD Medical”; stock code: 01931) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for IVD Medical on PhillipMart were HK\$3.16 and HK\$2.96. The price closed at HK\$3.05 per share, 0.65% lower than its offer price of HK\$3.07. The price opened at HK\$3.11, with the most actively traded price of HK\$3.1 per share, and a turnover of 447,000 shares. The total trading volume reached 2,939,000shares with **total turnover of HK\$8,983,950**. The final price of IVD Medical, to debut trading tomorrow has been fixed at HK\$3.07 per share.
