

**PhillipMart Announces Pre-IPO Share Price of
 Analogue Holdings Limited (Stock code: 01977)**

(Hong Kong – 11 Jul 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Analogue Holdings Limited (“Analogue Holdings”; stock code: 01977) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Analogue Holdings on PhillipMart were HK\$1.15 and HK\$1.00. The price closed at HK\$1.09 per share, 9.17% lower than its offer price of HK\$1.2. The price opened at HK\$1.00, with the most actively traded price of HK\$1.1 per share, and a turnover of 10,954,000 shares. The total trading volume reached 22,278,000 shares with **total turnover of HK\$24,466,120**. The final price of Analogue Holdings, to debut trading tomorrow has been fixed at HK\$1.2 per share.
