

**PhillipMart Announces Pre-IPO Share Price of
 Hevol Services Group Co. Limited (Stock code: 06093)**

(Hong Kong – 11 Jul 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Hevol Services Group Co. Limited (“Hevol Services”; stock code: 06093) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Hevol Services on PhillipMart were HK\$1.94 and HK\$1.49. The price closed at HK\$1.9 per share, 48.44% higher than its offer price of HK\$1.28. The price opened at HK\$1.49, with the most actively traded price of HK\$1.9 per share, and a turnover of 446,000 shares. The total trading volume reached 2,836,000shares with **total turnover of HK\$5,118,060**. The final price of Hevol Services, to debut trading tomorrow has been fixed at HK\$1.28 per share.
