

**PhillipMart Announces Pre-IPO Share Price of  
 Edvantage Group Holdings Limited (Stock code: 00382)**

(Hong Kong – 15 Jul 2019 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Edvantage Group Holdings Limited (“Edvantage Group”; stock code: 00382) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Edvantage Group on PhillipMart were HK\$2.91 and HK\$2.74. The price closed at HK\$2.87 per share, 0.7% higher than its offer price of HK\$2.85. The price opened at HK\$2.85, with the most actively traded price of HK\$2.88 per share, and a turnover of 396,000 shares. The total trading volume reached 2,040,000shares with **total turnover of HK\$5,810,780**. The final price of Edvantage Group, to debut trading tomorrow has been fixed at HK\$2.85 per share.
