

**PhillipMart Announces Pre-IPO Share Price of
 Kelfred Holdings Limited (Stock code: 01134)**

(Hong Kong – 15 Jul 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Kelfred Holdings Limited (“Kelfred”; stock code: 01134) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Kelfred on PhillipMart were HK\$1.44 and HK\$1.21. The price closed at HK\$1.29 per share, 29% than its offer price of HK\$1. The price opened at HK\$1.44, with the most actively traded price of HK\$1.3 per share, and a turnover of 1,884,000 shares. The total trading volume reached 7,752,000shares with **total turnover of HK\$9,965,120**. The final price of Kelfred, to debut trading tomorrow has been fixed at HK\$1 per share.
