

**PhillipMart Announces Pre-IPO Share Price of
 Contel Technology Company Limited (Stock code: 01912)**

(Hong Kong – 15 Jul 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Contel Technology Company Limited (“Contel”; stock code: 01912) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Contel on PhillipMart were HK\$0.84 and HK\$0.75. The price closed at HK\$0.82 per share, 26.15% higher than its offer price of HK\$0.65. The price opened at HK\$0.75, with the most actively traded price of HK\$0.8 per share, and a turnover of 4,095,000 shares. The total trading volume reached 24,110,000 shares with **total turnover of HK\$19,377,700**. The final price of Contel, to debut trading tomorrow has been fixed at HK\$0.65 per share.
