

**PhillipMart Announces Pre-IPO Share Price of
 Platt Nera International Limited (Stock code: 01949)**

(Hong Kong – 15 Jul 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Platt Nera International Limited (“Platt Nera”; stock code: 01949) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Platt Nera on PhillipMart were HK\$1.67 and HK\$1.35. The price closed at HK\$1.62 per share, 29.6% higher than its offer price of HK\$1.25. The price opened at HK\$1.35, with the most actively traded price of HK\$1.6 per share, and a turnover of 1,130,000 shares. The total trading volume reached 5,214,000shares with **total turnover of HK\$8,318,360**. The final price of Platt Nera, to debut trading tomorrow has been fixed at HK\$1.25 per share.
