

**PhillipMart Announces Pre-IPO Share Price of**

Zhongliang Holdings Group Company Limited (Stock code: 02772)

(Hong Kong – 15 Jul 2019 ) Phillip Securities (HK) Ltd. (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Zhongliang Holdings Group Company Limited (“Zhongliang Hldg”; stock code: 02772) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Zhongliang Hldg on PhillipMart were HK\$5.59 and HK\$5.3. The price closed at HK\$5.46 per share, 1.62% lower than its offer price of HK\$5.55. The price opened at HK\$2.55, with the most actively traded price of HK\$5.46 per share, and a turnover of 898,000shares. The total trading volume reached 3,228,500shares with **total turnover of HK\$17,550,865.00**. The final price of Zhongliang Hldg, to debut trading tomorrow has been fixed at HK\$5.55 per share.
