

**PhillipMart Announces Pre-IPO Share Price of
 Kimou Environmental Holding Limited (Stock code: 06805)**

(Hong Kong – 15 Jul 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Kimou Environmental Holding Limited (“Kimou Env”; stock code: 06805) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Kimou Env on PhillipMart were HK\$1.4 and HK\$1.21. The price closed at HK\$1.36 per share, 2.26% higher than its offer price of HK\$1.33. The price opened at HK\$1.37, with the most actively traded price of HK\$1.33 per share, and a turnover of 484,000 shares. The total trading volume reached 1,880,000shares with **total turnover of HK\$2,467,980**. The final price of Kimou Env, to debut trading tomorrow has been fixed at HK\$1.33 per share.
