

**PhillipMart Announces Pre-IPO Share Price of
 Jinshang Bank Co., Ltd (Stock code: 2558)**

(Hong Kong – 17 Jul 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Jinshang Bank Co., Ltd (“Jinshang Bank”; stock code: 2558) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Jinshang Bank on PhillipMart were HK\$4.15 and HK\$3.82. The price closed at HK\$3.92 per share, 2.62% higher than its offer price of HK\$3.82. The price opened at HK\$4.1, with the most actively traded price of HK\$3.92 per share, and a turnover of 120,000 shares. The total trading volume reached 903,000 shares with **total turnover of HK\$3,590,710**. The final price of Jinshang Bank, to debut trading tomorrow has been fixed at HK\$3.82 per share.
