

**PhillipMart Announces Pre-IPO Share Price of
 DA YU FINANCIAL HOLDINGS LIMITED (Stock code: 01073)**

(Hong Kong – 25 Jul 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of DA YU FINANCIAL HOLDINGS LIMITED (“DA YU FIN”; stock code: 01073) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for DA YU FIN on PhillipMart were HK\$0.53 and HK\$0.41. The price closed at HK\$0.44 per share, 15.38% lower than its offer price of HK\$0.52. The price opened at HK\$0.52, with the most actively traded price of HK\$0.425 per share, and a turnover of 1,120,000 shares. The total trading volume reached 7,380,000shares with **total turnover of HK\$3,329,125**. The final price of DA YU FIN, to debut trading tomorrow has been fixed at HK\$0.52 per share.
