

**PhillipMart Announces Pre-IPO Share Price of
 Hands Form Holdings Limited (Stock code: 1920)**

(Hong Kong – 15 Aug 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Hands Form Holdings Limited (“Hands Form Holdings”; stock code: 1920) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Hands Form Holdings on PhillipMart were HK\$0.25 and HK\$0.147. The price closed at HK\$0.162 per share, 19% lower than its offer price of HK\$0.2. The price opened at HK\$0.22, with the most actively traded price of HK\$0.154 per share, and a turnover of 4,520,000 shares. The total trading volume reached 71,010,000shares with **total turnover of HK\$12,315,640**. The final price of Hands Form Holdings, to debut trading tomorrow has been fixed at HK\$0.2 per share.
