

PhillipMart Announces Pre-IPO Share Price of TBK & Sons Holdings Limited (Stock code: 1960)

(Hong Kong – 27 Sep 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of TBK & Sons Holdings Limited ("TBK & Sons"; stock code: 1960) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for TBK & Sons on PhillipMart were HK\$0.8 and HK\$0.58. The price closed at HK\$0.73 per share, 46% higher than its offer price of HK\$0.5. The price opened at HK\$0.58, with the most actively traded price of HK\$0.7 per share, and a turnover of 3,060,000 shares. The total trading volume reached 9,190,000 shares with **total turnover of HK\$6,492,550**. The final price of TBK & Sons, to debut trading 30 Sep 2019. It has been fixed at HK\$0.5 per share.
