

**PhillipMart Announces Pre-IPO Share Price of
 LFG Investment Holdings Limited (Stock code: 3938)**

(Hong Kong – 27 Sep 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of LFG Investment Holdings Limited (“LFG Investment”; stock code: 3938) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for LFG Investment on PhillipMart were HK\$1.82 and HK\$1.5. The price closed at HK\$1.65 per share, 1.79% lower than its offer price of HK\$1.68. The price opened at HK\$1.68, with the most actively traded price of HK\$1.7 per share, and a turnover of 996,000 shares. The total trading volume reached 5,816,000shares with **total turnover of HK\$9,631,500**. The final price of LFG Investment, to debut trading at 30 Sep 2019. It has been fixed at HK\$1.68 per share.
