

**PhillipMart Announces Pre-IPO Share Price of
 FriendTimes Inc. (Stock code: 6820)**

(Hong Kong – 4 Oct 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of FriendTimes Inc. (“FriendTimes Inc.”; stock code: 6820) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for FriendTimes Inc. on PhillipMart were HK\$1.68 and HK\$1.52. The price closed at HK\$1.53 per share, 0.66% higher than its offer price of HK\$1.52. The price opened at HK\$1.64, with the most actively traded price of HK\$1.54 per share, and a turnover of 1,016,000 shares. The total trading volume reached 4,370,000shares with **total turnover of HK\$6,861,560**. The final price of FriendTimes Inc., to debut trading at 8 Oct 2019. It has been fixed at HK\$1.52 per share.
