

## PhillipMart Announces Pre-IPO Share Price of 360 Ludashi Holdings Limited (Stock code: 3601)

(Hong Kong – 9 Oct 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of 360 Ludashi Holdings Limited ("Ludashi"; stock code: 3601) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Ludashi on PhillipMart were HK\$4 and HK\$3.18. The price closed at HK\$3.75 per share, 38.89% higher than its offer price of HK\$2.7. The price opened at HK\$3.18, with the most actively traded price of HK\$3.4 per share, and a turnover of 564,000 shares. The total trading volume reached 9,308,000shares with **total turnover of HK\$33,412,890**. The final price of Ludashi, to debut trading tomorrow has been fixed at HK\$2.7 per share.
