

## PhillipMart Announces Pre-IPO Share Price of Xinyuan Property Management Service (Cayman) Ltd. (Stock code: 1895)

(Hong Kong – 10 Oct 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Xinyuan Property Management Service (Cayman) Ltd. ("Xinyuan PM"; stock code: 1895) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Xinyuan PM on PhillipMart were HK\$3 and HK\$2.11. The price closed at HK\$2.35 per share, 12.98% higher than its offer price of HK\$2.08. The price opened at HK\$2.6, with the most actively traded price of HK\$2.35 per share, and a turnover of 972,000 shares. The total trading volume reached 11,418,000shares with **total turnover of HK\$27,265,520**. The final price of Xinyuan PM, to debut trading tomorrow has been fixed at HK\$2.08 per share.

In view of customers demand, Phillip Securities announce that the trading hours of PhillipMart has be changed from 4:30p.m. - 6:00p.m. to 4:15p.m.-6:30p.m. effective from Thursday, 29 March 2012.
