

PhillipMart Announces Pre-IPO Share Price of Optima Automobile Group Holdings Limited (Stock code: 8418)

(Hong Kong – 10 Oct 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Optima Automobile Group Holdings Limited ("Optima Auto"; stock code: 8418) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Optima Auto on PhillipMart were HK\$0.33 and HK\$0.245. The price closed at HK\$0.255 per share, 6.25% higher than its offer price of HK\$0.24. The price opened at HK\$0.265, with the most actively traded price of HK\$0.248 per share, and a turnover of 3,750,000 shares. The total trading volume reached 28,790,000 shares with **total turnover of HK\$8,109,610**. The final price of Optima Auto, to debut trading tomorrow has been fixed at HK\$0.24 per share.
