

## PhillipMart Announces Pre-IPO Share Price of EuroEyes International Eye Clinic Limited (Stock code: 1846)

(Hong Kong – 14 Oct 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of EuroEyes International Eye Clinic Limited ("EuroEyes"; stock code: 1846) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for EuroEyes on PhillipMart were HK\$13 and HK\$8.5. The price closed at HK\$12.88 per share, 71.73% higher than its offer price of HK\$7.5. The price opened at HK\$8.5, with the most actively traded price of HK\$11 per share, and a turnover of 794,000 shares. The total trading volume reached 6,517,000shares with **total turnover of HK\$75,006,260**. The final price of EuroEyes, to debut trading tomorrow has been fixed at HK\$7.5 per share.
