

**PhillipMart Announces Pre-IPO Share Price of
 CR Construction Group Holdings Limited (Stock code: 1582)**

(Hong Kong – 15 Oct 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of CR Construction Group Holdings Limited (“CR Construction”; stock code: 1582) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CR Construction on PhillipMart were HK\$2.38 and HK\$1.5. The price closed at HK\$2.28 per share, 128% higher than its offer price of HK\$1. The price opened at HK\$1.5, with the most actively traded price of HK\$1.8 per share, and a turnover of 602,500 shares. The total trading volume reached 7,970,000shares with **total turnover of HK\$16,072,650**. The final price of CR Construction, to debut trading tomorrow has been fixed at HK\$1 per share.
