

## PhillipMart Announces Pre-IPO Share Price of Hong Kong Johnson Holdings Co., Ltd. (Stock code: 1846)

(Hong Kong – 15 Oct 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Hong Kong Johnson Holdings Co., Ltd. ("Johnson Holdings"; stock code:1955) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Johnson Holdings on PhillipMart were HK\$1.6 and HK\$1.15. The price closed at HK\$1.48 per share, 48% higher than its offer price of HK\$1. The price opened at HK\$1.15, with the most actively traded price of HK\$1.45 per share, and a turnover of 6,556,000 shares. The total trading volume reached 40,336,000shares with **total turnover of HK\$57,101,180**. The final price of Johnson Holdings, to debut trading tomorrow has been fixed at HK\$1 per share.
