

**PhillipMart Announces Pre-IPO Share Price of
 CENTENARY UNITED HOLDINGS LIMITED (Stock code: 1959)**

(Hong Kong – 17 Oct 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of CENTENARY UNITED HOLDINGS LIMITED (“CENTENARY UNITED”; stock code: 1959) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CENTENARY UNITED on PhillipMart were HK\$1.42 and HK\$1.09. The price closed at HK\$1.16 per share, 7.41% higher than its offer price of HK\$1.08. The price opened at HK\$1.4, with the most actively traded price of HK\$1.18 per share, and a turnover of 2,198,000 shares. The total trading volume reached 12,150,000 shares with **total turnover of HK\$14,237,280**. The final price of CENTENARY UNITED, to debut trading tomorrow has been fixed at HK\$1.08 per share.
