

**PhillipMart Announces Pre-IPO Share Price of
 Confidence Intelligence Holdings Limited (Stock code: 1967)**

(Hong Kong – 17 Oct 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Confidence Intelligence Holdings Limited (“Confidence Intelligence”; stock code: 1967) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Confidence Intelligence on PhillipMart were HK\$3.48 and HK\$2.65. The price closed at HK\$3.14 per share, 57% higher than its offer price of HK\$2. The price opened at HK\$2.98, with the most actively traded price of HK\$3.1 per share, and a turnover of 134,000 shares. The total trading volume reached 1,496,000shares with **total turnover of HK\$4,615,420**. The final price of Confidence Intelligence, to debut trading tomorrow has been fixed at HK\$2 per share.
