

PhillipMart Announces Pre-IPO Share Price of SNACK EMPIRE HOLDINGS LIMITED (Stock code: 1843)

(Hong Kong – 22 Oct 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of SNACK EMPIRE HOLDINGS LIMITED ("SNACK EMPIRE"; stock code: 1843) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for SNACK EMPIRE on PhillipMart were HK\$1.28 and HK\$0.87. The price closed at HK\$1.21 per share, 86.15% higher than its offer price of HK\$0.65. The price opened at HK\$0.87, with the most actively traded price of HK\$1.12 per share, and a turnover of 1,716,000 shares. The total trading volume reached 11,244,000shares with **total turnover of HKD12,806,280.00**. The final price of **SNACK EMPIRE**, to debut trading tomorrow has been fixed at HK\$0.65 per share.
