

**PhillipMart Announces Pre-IPO Share Price of  
 Ascentage Pharma Group International (Stock code: 06855)**

(Hong Kong – 25 Oct 2019 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Ascentage Pharma Group International (“Ascentage”; stock code: 06855) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Ascentage on PhillipMart were HK\$52.5 and HK\$39.8. The price closed at HK\$52.1 per share, 52.34% higher than its offer price of HK\$34.2. The price opened at HK\$39.8, with the most actively traded price of HK\$50 per share, and a turnover of 108,700 shares. The total trading volume reached 1,851,900shares with **total turnover of HK\$89,789,025.00**. The final price of Ascentage, to debut trading at 28 Oct. It has been fixed at HK\$34.2 per share.
