

PhillipMart Announces Pre-IPO Share Price of Yincheng Life Service CO., Ltd. (Stock code: 1922)

(Hong Kong – 5 Nov 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Yincheng Life Service CO., Ltd. ("Yincheng LS"; stock code: 1922) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Yincheng LS on PhillipMart were HK\$2.65 and HK\$2.3. The price closed at HK\$2.43 per share, 11.46% higher than its offer price of HK\$2.18. The price opened at HK\$2.51, with the most actively traded price of HK\$2.42 per share, and a turnover of 1,560,000 shares. The total trading volume reached 12,310,000 shares with **total turnover of 29,828,340.00**. The final price of Yincheng LS, to debut trading tomorrow has been fixed at HK\$2.18 per share.
