

## PhillipMart Announces Pre-IPO Share Price of Changsha Broad Homes Industrial Group Co., Ltd. (Stock code: 2163)

(Hong Kong – 5 Nov 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Changsha Broad Homes Industrial Group Co., Ltd. ("Broad Homes"; stock code: 2163) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Broad Homes on PhillipMart were HK\$9.25 and HK\$8.06. The price closed at HK\$9.21 per share, the same than its offer price of HK\$9.68. The price opened at HK\$8.06, with the most actively traded price of HK\$9.1 per share, and a turnover of 122,400 shares. The total trading volume reached 754,200 shares with **total turnover of 6,893,646.00**. The final price of Broad Homes, to debut trading tomorrow has been fixed at HK\$9.68 per share.
