PhillipMart Announces Pre-IPO Share Price of Shanghai Kindly Medical Instruments Co., Ltd. (Stock code: 1501)

(Hong Kong – 7 Nov 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Shanghai Kindly Medical Instruments Co., Ltd. ("KDL Medical"; stock code: 1501) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for KDL Medical on PhillipMart were HK\$25.95 and HK\$23.9. The price closed at HK\$25.75 per share, 23.8% higher than its offer price of HK\$20.8. The price opened at HK\$24.2, with the most actively traded price of HK\$25.5 per share, and a turnover of 308,000 shares. The total trading volume reached 4,021,800 shares with **total turnover of 101,247,150.00**. The final price of KDL Medical, to debut trading tomorrow has been fixed at HK\$20.8 per share.
