

PhillipMart Announces Pre-IPO Share Price of Acme International Holdings Limited (Stock code: 1870)

(Hong Kong – 7 Nov 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Acme International Holdings Limited ("Acme Int"; stock code: 1870) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Acme Int on PhillipMart were HK\$1.24 and HK\$1.02. The price closed at HK\$1.15 per share, 18.6% higher than its offer price of HK\$0.97. The price opened at HK\$1.14, with the most actively traded price of HK\$1.14 per share, and a turnover of 892,500 shares. The total trading volume reached 4,427,500 shares with **total turnover of 5,075,850.00**. The final price of Acme Int, to debut trading tomorrow has been fixed at HK\$0.97 per share.
