

PhillipMart Announces Pre-IPO Share Price of Dalipal Holdings Limited (Stock code: 01921)

(Hong Kong – 7 Nov 2019) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Dalipal Holdings Limited** ("Dalipal Holdings"; stock code: 01921) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Dalipal Holdings** on PhillipMart were HK\$1.7 and HK\$1.5. The price closed at HK\$1.68 per share, 5.66% higher than its offer price of HK\$1.59. The price opened at HK\$1.5, with the most actively traded price of HK\$1.6 per share, and a turnover of 1,874,000 shares. The total trading volume reached 4,824,000 shares with **total turnover of \$7,619,580.00**. The final price of **Dalipal Holdings**, to debut trading tomorrow has been fixed at HK\$1.59 per share.
