

PhillipMart Announces Pre-IPO Share Price of Lever Style Corporation (Stock code: 1346)

(Hong Kong – 12 Nov 2019) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Lever Style Corporation ("Lever Style"; stock code: 1346) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Lever Style on PhillipMart were HK\$0.9 and HK\$0.75. The price closed at HK\$0.75 per share, 11.76% lower than its offer price of HK\$0.85. The price opened at HK\$0.87, with the most actively traded price of HK\$0.77 per share, and a turnover of 2,180,000 shares. The total trading volume reached 8,468,000 shares with **total turnover of HK\$6,650,680**. The final price of Lever Style, to debut trading tomorrow has been fixed at HK\$0.85 per share.
