

## PhillipMart Announces Pre-IPO Share Price of HOME CONTROL INTERNATIONAL LIMITED (Stock code: 1747)

(Hong Kong – 13 Nov 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of HOME CONTROL INTERNATIONAL LIMITED ("HOME CONTROL INT"; stock code: 1747) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for HOME CONTROL INT on PhillipMart were HK\$1.02 and HK\$0.82. The price closed at HK\$1.02 per share same as its offer price of HK\$1.02. The price opened at HK\$1.02, with the most actively traded price of HK\$0.85 per share, and a turnover of 3,250,000 shares. The total trading volume reached 13,258,000 shares with **total turnover of HK\$11,778,960**. The final price of HOME CONTROL INT, to debut trading tomorrow has been fixed at HK\$1.02 per share.
