

**PhillipMart Announces Pre-IPO Share Price of
 Orange Tour Cultural Holding Limited (Stock code: 8627)**

(Hong Kong – 13 Nov 2019) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Orange Tour Cultural Holding Limited (“Orange Tour Cultural”; stock code: 8627) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Orange Tour Cultural on PhillipMart were HK\$0.315 and HK\$0.208. The price closed at HK\$0.3 per share, 10.09% lower than its offer price of HK\$0.275. The price opened at HK\$0.26, with the most actively traded price of HK\$0.3 per share, and a turnover of 2,180,000 shares. The total trading volume reached 23,032,000shares with **total turnover of HK\$6,819,824**. The final price of Orange Tour Cultural, to debut trading tomorrow has been fixed at HK\$0.275 per share.
