

PhillipMart Announces Pre-IPO Share Price of BEST LINKING GROUP HOLDINGS LIMITED (Stock code: 8617)

(Hong Kong – 14 Nov 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of BEST LINKING GROUP HOLDINGS LIMITED ("BEST LINKING"; stock code: 8617) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for BEST LINKING on PhillipMart were HK\$0.6 and HK\$0.5. The price closed at HK\$0.53 per share same as its offer price of HK\$0.55. The price opened at HK\$0.57, with the most actively traded price of HK\$0.55 per share, and a turnover of 3,060,000 shares. The total trading volume reached 13,245,000shares with **total turnover of HK\$7,055,500**. The final price of BEST LINKING, to debut trading tomorrow has been fixed at HK\$0.55 per share.
