

PhillipMart Announces Pre-IPO Share Price of Huali University Group Limited (Stock code: 1756)

(Hong Kong – 22 Nov 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Huali University Group Limited ("Huali Uni"; stock code: 1756) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Huali Uni on PhillipMart were HK\$3.18 and HK\$2.92. The price closed at HK\$2.95 per share, 9.51% lower than its offer price of HK\$3.26. The price opened at HK\$3.16, with the most actively traded price of HK\$3.03 per share, and a turnover of 407,000 shares. The total trading volume reached 2,894,000shares with **total turnover of HK\$8,734,540**. The final price of Huali Uni, to debut trading at 25 Nov. It has been fixed at HK\$3.26 per share.
