

PhillipMart Announces Pre-IPO Share Price of WMCH Global Investment Limited (Stock code: 08208)

(Hong Kong – 28 Nov 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of WMCH Global Investment Limited ("WMCH Global"; stock code: 08208) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for WMCH Global on PhillipMart were HK\$0.51 and HK\$0.44. The price closed at HK\$0.46 per share, 15% higher than its offer price of HK\$0.4. The price opened at HK\$0.5, with the most actively traded price of HK\$0.46 per share, and a turnover of 5,112,000 shares. The total trading volume reached 27,474,000 shares with **total turnover of HK\$12,865,230**. The final price of WMCH Global, to debut trading tomorrow has been fixed at HK\$0.4 per share.
