

PhillipMart Announces Pre-IPO Share Price of ALPHAMAB ONCOLOGY (Stock code: 9966)

(Hong Kong – 11 Dec 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of ALPHAMAB ONCOLOGY ("ALPHAMAB ONCOLOGY"; stock code: 9966) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for ALPHAMAB ONCOLOGY on PhillipMart were HK\$13.2 and HK\$11.02. The price closed at HK\$12.76 per share, 25.1% higher than its offer price of HK\$10.2. The price opened at HK\$11.5, with the most actively traded price of HK\$13 per share, and a turnover of 1,848,000 股 shares. The total trading volume reached 24,915,000 shares with **total turnover of HK\$302,538,000**. The final price of ALPHAMAB ONCOLOGY, to debut trading tomorrow has been fixed at HK\$10.2 per share.
