

## PhillipMart Announces Pre-IPO Share Price of Chen Lin Education Group Holdings Limited (Stock code: 1593)

(Hong Kong – 12 Dec 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Chen Lin Education Group Holdings Limited ("Chen Lin Edu"; stock code: 1593) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Chen Lin Edu on PhillipMart were HK\$2.29 and HK\$2.2. The price closed at HK\$2.21 per share, 0.45% higher than its offer price of HK\$2.2. The price opened at HK\$2.2, with the most actively traded price of HK\$2.25 per share, and a turnover of 1,500,000 shares. The total trading volume reached 4,114,000shares with **total turnover of HK\$9,218,000**. The final price of Chen Lin Edu, to debut trading tomorrow has been fixed at HK\$2.2 per share.
