

PhillipMart Announces Pre-IPO Share Price of Renrui Human Resources Technology Holdings Limited (Stock code: 6919)

(Hong Kong – 12 Dec 2019) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Renrui Human Resources Technology Holdings Limited ("Renrui HR"; stock code: 6919) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Renrui HR on PhillipMart were HK\$26.6 and HK\$25.1. The price closed at HK\$25.25 per share, 5.08% lower than its offer price of HK\$26.6. The price opened at HK\$26.6, with the most actively traded price of HK\$25.3 per share, and a turnover of 65,700 shares. The total trading volume reached 231,500shares with **total turnover of HK\$5,898,075**. The final price of Renrui HR, to debut trading tomorrow has been fixed at HK\$26.6 per share.
