

## PhillipMart Announces Pre-IPO Share Price of MAIKE TUBE INDUSTRY HOLDINGS LIMITED (Stock code: 1553)

(Hong Kong – 17 Dec 2019) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of MAIKE TUBE INDUSTRY HOLDINGS LIMITED ("MAIKE TUBE"; stock code: 1553) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for MAIKE TUBE on PhillipMart were HK\$5.19 and HK\$2.4. The price closed at HK\$4.95 per share, 117.11% higher than its offer price of HK\$2.28. The price opened at HK\$2.48, with the most actively traded price of HK\$4.93 per share, and a turnover of 232,000 shares. The total trading volume reached 3,444,000shares with **total turnover of HK\$14,764,240**. The final price of MAIKE TUBE, to debut trading tomorrow has been fixed at HK\$2.28 per share.
